### TERAC Annual Meeting

The meeting will be in the Round Table pizza party room. The club will host pizza and drinks starting at 6 PM for this meeting. The meeting will start at 7:15 PM. This meeting does not effect the Christmas dinner scheduled for Saturday December 10.

As noted in the banner, this newsletter is an official notice of the TERAC annual meeting. The Annual Meeting is specified by our bylaws to occur in November or December. Certain activities are spelled out to occur at this meeting. They include:

- Election of officers and board members for the following year.
- Treasurer's report, recommended budget, and recommended dues for following year.
- Vote by members to approve budget and dues for the following year.

- Station trustee report on any changes of inventory of club property.

Note that this year the Station Trustee is up for reelection. That occurs every several years based on license terms. Note also that we have a vacancy in the secretary position. In addition to the election for the 2012 year, we will have an election to fill the unexpired term.

- Club contributions.

It would also be a time to discuss other topics such as club direction, web page, or other issues from members. The required quorum for the meeting is nine members at least three of whom are on the Board of Directors. So, please attend!

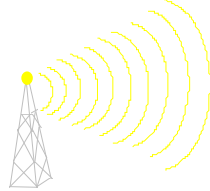
